**Tuition takes into account the ongoing costs of building maintenance, technology upgrades and school expansion.
 *Families can purchase a maximum of one (1) punch card per month, per student/family.
 *Families paying **K-8 tuition** in full by Aug. 1st, 2021, will receive a \$100 discount.*

METHODS OF PAYMENT

MONTHLY: 10 equal monthly payments starting on Sept 1st, 2021 and ending June 1st, 2022. Complete Pre-Authorized Debit form and attach a void cheque.

MONTHLY: 12 equal monthly payments starting on July 1st, 2021 and ending June 1st, 2022. Complete Pre-Authorized Debit form and attach a void cheque. (only available for grades K-8 tuition payments)

FAMILY PLAN: Full tuition is due for the **first** and **second** child from each family, youngest to oldest, and tuition payable for **each additional** child is **\$350.00**.

BASC FAMILY PLAN: Full BASC amount is due for the **first** and **second** child from each family and the amount payable for **each additional** child is **\$200.00**.

VOLUNTEER FEES & HOURS:

Families must provide two (2) \$100.00 post dated cheques per student dated December 31st, 2021 & June 30th, 2022. Cheques will be destroyed if volunteer commitment is fulfilled. (refer to the "Volunteer Declaration")

CHARITABLE & CHILDCARE RECEIPTS:

Charitable receipts may be issued for a portion of Kindergarten to Grade 8 tuition payments that are in excess of the operating "cost per pupil" provided by external auditors. Annual child-care receipts, including Pre-Kindergarten, will be issued for child care received for 2021 in 2022. The Hockey Academy does not qualify for any tax credits. All applicable tax receipts will be issued by February 28th, 2022.

LATE ADMISSION:

The admissions cut-off date for the current school year will be September 30th of that year. Students must be registered and in attendance by that date each school year. Applications for enrollment accepted from October to December 31st will be charged full tuition. Tuition for students enrolling from January to June, will be pro-rated, if accepted.

OUTSTANDING ACCOUNTS:

Re-registrations will not be accepted until outstanding accounts are paid in full, or a payment plan has been arranged with the finance office. ** Credit card payments will be accepted to pay outstanding balances from previous year**

INSUFFICIENT FUNDS:

There is a \$5.00 charge for all PAD payments returned due to insufficient funds and a \$45.00 charge for all cheques returned due to insufficient funds (NSF).
