Once you have been accepted for the new school year, you will receive a financial form via email from the finance office swilkinson@stemileschool.com

Once you have completed the financial form your methods of payment are:

PAYMENT IN FULL: Submit an **INDIVIDUAL CHEQUE FOR EACH STUDENT** (by June 15th 2026) **postdated to August 1st, 2026** or e-transfer the tuition for **EACH STUDENT SEPARATELY** to swilkinson@stemileschool.com between July 1st - 31st 2026 exclusively.

Students Kindergarten-Grade 8 will receive a \$100 discount when the tuition is paid in full. (\$200 max discount) or

MONTHLY: 10 equal monthly payments starting on September 1st, 2026 and ending June 1st, 2027. (Drawn on the 1st of each month) Reminder: We require you to submit banking information every year with a signed PAD form.

Pre-Kindergarten and BASC: Please note that **these can only be paid monthly by Pre-Authorized Debit (PAD 10)** and cannot be paid in full. Reminder: We require you to submit banking information every year with a signed PAD form.

BASC MULTI STUDENT DISCOUNT: Full BASC amount is due for the **first** and **second** child from each family via 10 monthly payments only, then **each additional** child is **\$200.00**. Your Pre authorized debit will be separate from tuition and separate for each child and will be drawn on the 15th of each month. For families with more than 2 children the total price of all children will be equally invoiced to each child.

Volunteer Option: Families may choose to complete **8 hours of volunteer service** during the school year.

To select this option, a **\$300 deposit cheque** is required by **June 15, 2026**, post-dated to **June 15, 2027**.

The cheque will be **destroyed once the 8 volunteer hours are completed**.

If the hours are **not completed**, the cheque will be **deposited in June 2027**.

Non-Volunteer Option: Families who prefer not to volunteer may instead pay a **\$300 non-volunteer fee**.

A cheque for \$300 is due by **June 15, 2026**, post-dated to **September 1, 2026** and will be deposited in September 2026.

CHARITABLE & CHILDCARE RECEIPTS:

Charitable receipts may be issued for a portion of Kindergarten to Grade 8 tuition payments that are in excess of the operating "cost per pupil" provided by external auditors. Annual child-care receipts, including Pre-Kindergarten, will be issued for child care received for 2026..

The Sports Programs do not qualify for any tax credits. All applicable tax receipts will be issued by February 28th, 2027.

LATE ADMISSION:

The admissions cut-off date is September 30th. Students must be registered and in attendance by that date each school year. Applications for enrollment accepted from October to December 31st will be charged full tuition.

Tuition or students enrolling from January to June, will be pro-rated, if accepted.

OUTSTANDING ACCOUNTS:

Re-registrations will NOT be accepted until outstanding accounts are paid in full, or a payment plan has been arranged with the finance office.
